- Utilize creativity in rehabilitative interventions to help clients achieve goals
- Develop relationships with, teach skills to, and support clients as they work towards individual goals
- Alleviate barriers to assist client's integration into the community
- Coordinate services with case managers, families/legal guardians of clients, work personnel, and medical personnel as appropriate
- Complete all required client paperwork, including Functional Assessment, Interpretive Summary, LOCUS and Individual Treatment Plan per company guidelines and protocol
- Utilize Illness Management and Recovery as defined by Adult Rehabilitative Mental Health Services (ARMHS)
- Maintain minimum 30 billable hours weekly
- Attend and participate in all ARMHS staff meetings and trainings
- Other duties as assigned

Qualifications

Education and/or Experience:

ARMHS Mental Health Practitioners providing services for the treatment of mental illness must be qualified in at least *one of the following four ways*:

- Hold a bachelor's degree in a behavioral science or related field from an accredited college or university and has at least 2,000 hours of supervised experience in a delivery of mental health services to recipients with mental illness
- Has at least 6,000 hours of supervised experience in the delivery of mental health services to recipients with mental illness.
- Is a graduate student in one of the mental health professional disciplines at an accredited college or university that formally assigns the student to an agency or facility for clinical training
- Holds a master's or other graduate degree in one of the mental health professional disciplines from an accredited college or university

Ideal candidates will have a general knowledge of ARMHS services, therapy services, and previous experience with mental health documentation
