Lee Carlson Center provides:

- One 4-foot table with linen
- Glass 5.5oz sampler glasses
- 5 entry-passes into the event for your team
- Staff to check IDs

Your brewery provides:

- Keg and tap (plan for 200 guests)
- Your best brew
- Extension cord and/or power strip
- A certificate of your insurance showing liquor liability coverage

Rules:

- Competition is open to any local brewery within the Twin Cities Metro area
- Participants are allowed two (2) types of beer per \$250 entry fee.
- The number of members per team cannot exceed 5 people.
- Competition is open to all recognized beer styles.
- Winners of the Chili Cook-Off and Beer Tasting Competition will retain all rights to their original recipe.
- Portions of the competition will be photographed. By accepting the terms of the contest, you authorize Lee Carlson Center to use photos in future material.
- Set-up begins at 3:30 and completed by 5:00 pm. At least 1 member of your team must be at the table until 8:30 pm.
- **Please provide a list of your team's beer ingredients by Friday, February 21st.** *We will be posting the ingredients at each table this year for those with allergies or food sensitivities.*
